## CVR Quarterly Letter – Q4 2015

The CVR Dynamic Allocation Fund (“the Fund”) is rule-based, unemotional and repeatable. Designed to participate in upward trending markets and to minimize losses in difficult markets, leading to the potential for an improved up/down capture ratio.

### Q4 Commentary


After a tumultuous third quarter during which the equity markets experienced significant drawdowns, the roller coaster ride continued during Q4. The S&P 500 traded up 9.5% in the first five weeks of the fourth quarter, more than recouping Q3’s decline of -6.44%. The S&P 500 finished up 7.03% for the quarter, the HFRX Equity Hedge Index was up 0.82% and the CVR Dynamic Allocation Fund returned -0.48% over the same period.

The Fund, whose risk models moved to a neutral/defensive position in the midst of the considerable equity volatility during Q3, remained in that stance entering Q4. The Defensive Equity strategy held a considerable cash position causing it to lag the broad equity market. The Focused Equity strategy also lagged, along with most value-oriented equity strategies.

Of note, the Defensive Equity strategy protected capital after the risk algorithm signaled that the Fund should exit its energy exposure in October 2014 and has kept the Fund out of energy since that time. As a result, the Defensive Equity strategy sidestepped a subsequent decline of more than -22% in energy. We believe this is a good example of how the strategy will respond to protect capital in the event of even broader equity market weakness.

Historically, equity markets that trade in wide and loose price ranges are an indication of increasing risk and a change in the general trend for equities. The S&P 500 finished the year below both its long (200 day) and short (50 day) term moving averages and has established a downtrend. Whatever the coming year may bring, the CVR Dynamic Allocation Fund incorporates a risk managed process that seeks to de-risk your equity portfolio while allowing for upside participation.

**Standard Deviation** is a measure of the dispersion of a set of data from its mean. Beta is the measure of a fund's relative volatility as compared to the S&P 500 Index. Beta attempts to measure the relative risk. A Beta rating above 1.0 indicates greater volatility than the market. A Beta rating below 1.0 indicates lower volatility than the market. **Sharpe Ratio** is a risk-adjusted measure calculated by using standard deviation and excess return to determine reward per unit of risk. The higher the Sharpe ratio, the better the fund's historical risk adjusted performance. **R-Squared** is the measure of percentage movement of a fund compared to the S&P 500 Index. A high R-Squared (between 85 and 100) indicates the Fund's performance patterns have been in line with the Index. **The S&P 500 Total Return Index** is a market capitalization-weighted index of 500 large-capitalization stocks commonly used to represent the U.S. equity market. All returns reflect reinvested dividends and capital gains distributions. One cannot invest directly in an index. **Liquid Alternatives** are any nontraditional asset with potential economic value that would not be found in a standard investment portfolio and trades with daily liquidity.
